**Sub:-Termination of your Rate Contract of Consumable Surgical items with IHBAS, Forfeiture of EMD/Security Deposit of Rs.50,000/- and Blacklisting your firm from IHBAS for participating in any tender for one year from the date of issue of the letter**

Please refer to the Contract No. 14/02/PS(M)/IHBAS/2019/784 dated 16.12.2019 for supply of Consumable Surgical items against Tender No. 14/02/PS(M)/IHBAS/2019 (Tender ID No. 2019\_IHBAS\_170329\_1) on 28.03.2019 and awarded the Supply Order No.14/02/PS(M)/IHBAS/2019/851 dated 17.02.2020 - valuing Rs.70,324/- and 14/02/PS(M)/IHBAS/2019/1008 dated 20.06.2020 - valuing Rs.1,09,625/-.

2. Whereas not supplied any items of the above-mentioned supply order. Clause No. 9 of the aforesaid Supply Order stipulates "If the firm fail to deliver the items within the validity/delivery period, it will be presumed that the firm is not interest in supplying the items and in such events, the Institute reserves the right to procure the ordered items from L-2 or other source at their risk and cost. The cost difference on this account will be borne by the firm. In addition, the Institute will have the right to forfeit their EMD in full and debar from participating in the tender invited by the Institute in future. This may include blacklisting too. The decision of the Director in the regard will be final and binding on the bidder".

3. Whereas due to non-supply of Consumable Surgical items as per the terms and condition of the tender. You were issued a Show Cause Notice No. 14/02/PS(M)/IHBAS/2019/1065 dated 02.09.2020 as to why you should not be blacklisted from participating in the tender by IHBAS in future and EMD may not be forfeited as you have violated the terms and condition of the tender. In addition, the expenditure so incurred on the purchases done so far on the risk and cost of your firm shall be recovered from your bills and EMD.

4. Whereas vide e-mail dated 02.09.2020 and letter dated 02.09.2020, you have replied to the Show Cause Notice that you are not able to supply against the above supply order. You do not want to continue Rate Contract with IHBAS, and you have also desired to terminate your contract. You have felt sorry for all issues that IHBAS has faced because of you.

5. Whereas you have violated the terms and conditions of the tender by declining the supply of Consumable Surgical items for the patient of the Institute. You have defeated the basic purpose of meeting the requirement of consumable surgical items for patient care service. Non-supply of Consumable Surgical by you has been viewed very seriously by the Institute.

6. However, your reply to the Show Cause Notice has been examined in accordance with the terms and condition of the tender, but not acceded to by the Competent Authority.

7. Therefore, in view of the above, the competent authority of this Institute has taken the following decision in this regard:-

- (a) Termination of Rate Contract with M/s Sanyog Healthcare Ltd., with immediate effect.
- (b) Blacklisting M/s Sanyog Healthcare from participation in the tendering of IHBAS for one year from the date of issue of this letter.
- (c) Forfeiture of your EMD of Rs.50,000/- furnished in the form of TDR No38348434908 dated 26.03.2019.

This issues with the approval of the Competent Authority of IHBAS.
